Free Drinking Water Sources:

Southern and Central Illinois

While there are few public outlets dedicated specifically to free drinking water, here are some accessible options you can explore:

1. Municipal Parks (Public Spigots & Facilities)

Many municipal parks in the region offer water access—usually through restrooms, splash pads, or potable spigots—available to visitors at no cost. These include:

- Edwardsville Parks: The city maintains a network of well-equipped parks open daily (6 AM-10 PM) .
- Glen Carbon Parks: Parks like Miner Park and Schon Park offer restroom facilities, which may have potable water access.

Tip: Before relying on park water, check signage or confirm with local authorities to ensure the spigots are safe for drinking.

2. Schools with Hydration Stations

H2O On the Go Program: Several schools—including in Madison County—received grant-funded water bottle filling stations. These shelters provide clean, filtered water for students and staff . Good to know: These are located inside school buildings and typically not available to the general public, but they demonstrate how public investment can increase access to safe drinking water.

3. Help with Private Well Testing & Sample Kits

Most local health departments can help test for bacteria and nitrate. Find your local health department by searching the internet or go to the Illinois health department directory. Testing for contaminants can be expensive. **IDPH can help interpret test results and provide appropriate recommendations for free.** IDPH cannot require you to test your well, install treatment, or keep you from using your well.

4. Water Utilities & Public Water Infrastructure

North East Central County Public Water District (Edwardsville, Madison County) provides reliable drinking water to thousands of residents .

Illinois-American Water serves much of the Metro East area, including parts of St. Clair County. They often offer discounted rates or assistance programs for income-qualified residents—not free water, but potential support.

Bond Madison Water -

Bond Madison Water Company provides clean potable water to residents and businesses in Bond and Madison Counties, ensuring a reliable and safe water supply at the lowest possible cost.

5. State Park Water Spigots

Parks across southern Illinois—including state parks and trailheads—typically offer free potable water via public spigots or faucets. These are commonly found near picnic areas or dump stations.

Important: Some spigots are labeled non-potable due to possible lead in fittings or hose attachments. Always verify with signage or park staff before consumption.

6 Clear Lake Township Water Fill Station

Located in southern Illinois Sangamon County (near Rochester), this station is publicly available 24 hours a day and was established with the Sugar Creek Water District. It's 100% free, but requires a 3-inch hose connection to use. https://www.clearlaketownship.net/services_waterstation.cfm

7. Hidden Springs State Forest

Named for its seven natural drinking springs, this forest in Shelby County offers a historical source of free water. While used historically by early settlers, current accessibility and safety for consumption may vary. https://dnr.illinois.gov/parks/park.hiddensprings.html

8. Illinois Office of Water Resources

- Research further? Use the Illinois EPA's Drinking Water Watch tool for data on your county's public water systems and quality reports.
